

STAUNTON-ON-WYE PRIMARY SCHOOL GOVERNOR DETAILS AND REGISTER OF INTERESTS 2016-2017

In the interests of transparency all schools and academies should publish, including on their website, up to date details of the structure of the governing body and any committees, together with the names of their governors and their particular roles and responsibilities within that structure. From September 2015 governing bodies will be under a duty to publish on their website their register of interests. The register should set out the relevant business interests of governors and details of any other educational establishments they govern. The register should also set out any relationships between governors and members of the school staff including spouses, partners and relatives.
